SNI (Standar Nasional Indonesia) is the Indonesian National Standard, overseen by the National Standardization Agency of Indonesia (BSN). The National Standardization Agency of Indonesia (Badan Standardisasi Nasional or BSN) is the primary government body responsible for setting and managing national standards, conformity assessment, and metrology activities.
